**I UNDERSTAND THAT THESE RISKS, HAZARDS, AND DANGERS INCLUDE WITHOUT LIMITATION:**

1. The risk of handling firearms and being near others that have firearms in their possession;
2. The risk of ear damage from noise;
3. The risk of injury from ammunition, and shot from other guns;
4. Walking in rugged and unfamiliar country, including encounters with wildlife, animals, insects and plants;
5. Inclement weather conditions. (heat, cold, rain)

**SAFETY RECOMMENDATIONS**

Tail Chaser Charters strongly recommends that you use ear plugs and protective eye glasses. If you do not use ear and eye protection you do so at your own risk.

I understand the risks, hazards, and dangers as described above and have had the opportunity to discuss them with Tail Chaser Charters. I understand that these activities may require good physical conditioning and a degree of skill and knowledge necessary for me to engage in these activities safely. I understand that I am responsible for the proper use of my safety equipment and my firearms. My participation in this activity is voluntary. No one is forcing me to participate and I elect to participate in spite of the risks.

NEGLIGENCE of any kind or nature, whether foreseen or unforeseen, arising directly or indirectly out of any damage, or injury, or death to me or my property as a result of my engaging in these activities or the use of these services, animals, property or equipment, whether such damage, loss, injury paralysis, or death results from negligence of Whitewing/Dove Hunting, Duck/Hunting, or from some other cause.
